This is a day run event starting at The Bridge Inn, North End Road, Yatton, North Somerset BS49 4AU where optional breakfasts will be available to purchase.

The run is around 90 miles and takes in a steam heritage venue for a lunch time stop. It will finish at the Mizzymead Recreation Centre, Mizzymead Rise, Nailsea BS48 2JJ with afternoon tea, the opportunity to socialise and possibly skittles to follow. We hope to include as many of the usual Brunel amusements as we can cram in!

The price of the run is £30 per car to include rally plaque, instructions etc.

Afternoon tea is £7.50 per person (not just a cream tea but a proper afternoon tea!).

[Afternoon teas should be booked separately on the form overleaf].


